BZA CHAIR HILL: All right, Ms. Mehlert, if you want to call our next one?

MS. MEHLERT: Yeah, so the board is going into its public meeting session. The first case is an expedited review application, number 21126 of Katie Abbodanza and Brendan Kearney. This is a self certified application pursuant to Subtitle X Section 901.2 for a special exception under Subtitle D Section 5201 from the accessory building location requirements of Subtitle D Section 5004.1(a).

This is to construct a rear addition to an existing two story detached principal dwelling with an existing accessory structure in the rear yard. It's located in the R-1B zone at 902 Butternut Street Northwest, Square 2968, Lot 17.

BZA CHAIR HILL: Okay, thank you. All right, so I've had the chance to review the record, and I thought that it was relatively straight forward. I didn't really have a lot of issues with it, I mean a screen porch enclosure, I don't think is going to have any effect on the light and air of the neighbors, as well as you can't really see it except for maybe from the alley.

And this probably wouldn't even be triggered except for the fact that there's already an accessory

1 building in the yard. The Office of Planning was in support,
2 the ANC also is in support, as were several neighbors in the
3 area, and I appreciate the applicant for reaching out and
4 providing all of the community input that they did provide.
5 I'm going to be voting in favor. Mr. Smith, do you have
6 anything you'd like to add?

7 MEMBER SMITH: I have nothing to add, Chairman
8 Hill, I agree with your account of this particular case, and
9 your position on this, and will also support the application.

10 BZA CHAIR HILL: Thank you. Dr. Imamura?

11 COMMISSIONER IMAMURA: I'm also in agreement with
12 Mr. Chair, I have nothing further to add.

21 an existing two story detached principal dwelling with an
22 accessory structure in the rear yard. This is located in the
23 R-1B zone of 4425 Warren Street Northwest, Square 1593, Lot
24 47.

1 to review the application in the record, I would agree with
2 the analysis that the Office of Planning has provided in
3 terms of the visibility, and privacy issues, and light and
4 air, and do not think that it would be unduly affected. I
5 appreciate that the applicant has reached out to the ANC, and
6 has gotten their support.

7 We, particularly in these expedited reviews, when
8 we don't have an opportunity to speak to the applicant, I
9 always want to see at least something that indicates what is
10 going on at the community level in terms of that it was an
11 expedited review, or is an expedited review, and therefore
12 I am comfortable voting in favor of this. As well as that
13 they've reached out to the adjacent properties, and have
14 garnered their support. I am going to be voting in favor.
15 Mr. Smith, do you have anything you'd like to add?

16 MEMBER SMITH: I have nothing to add, Chairman
17 Hill, I agree with your assessment and will vote in support.

18 BZA CHAIR HILL: Thank you. Dr. Imamura?
