VICE-CHAIRPERSON HOOD: Good evening, ladies and gentlemen. This is a public hearing of the Zoning Commission of the District of Columbia for Monday, July 24th, 2006. My name is Anthony J. Hood. Joining me this evening are Commissioners Gregory N. Jeffries, John G. Parsons and Michael G. Turnbull, full names this time. The subject of this evening's hearing is Zoning Commission Number 06-20.

This is a request from the Office of Planning for a text amendment to Title 11 of the District of Columbia Municipal Regulations Zoning to permit the use of a surface parking lot on Square 661, Lot 805 which is known as 98 R Street SW, by the Washington Metropolitan Transit Authority busses for a maximum period of five years. Notice of today's hearing was published in the DC Register on June 16th, 2006. Copies of today's hearing announcements are available to you and are located to my left on the table near the door.

The hearing will be conducted in accordance with the provisions of 11 DCMR 3021. The order of procedure will be as follows; preliminary matters, presentation by the Office of Planning,

2 6D, organizations and persons in support,
3 organizations and persons in opposition. The
4 following time constraints will be maintained in this
5 hearing, organizations five minutes, individuals three
6 minutes.

7 The Commission intends to maintain this
8 time limit as strictly as possible in order to hear
9 the case in a reasonable period of time. The
10 Commission reserves the right to change the time
11 limits for presentations, if necessary and those at

4 The decision of the Commission in this
5 case must be based on the public record. To avoid any
6 appearance to the contrary, the Commission requested
7 persons present not engage the members of the
8 Commission in conversations during a recess or at any
9 other time. The staff will be available throughout
10 the hearing to discuss procedural matters. Please
11 turn off all beepers and cell phones at this time so

1 Square 661, Lot 805. This is currently improved as a
2 parking lot by PEPCO and it is our understanding the
3 lot is currently not used for parking.

4 This initiative would allow relocation of
5 an existing WMATA bus parking currently located on the
6 future ball park site. It's associated with the WMATA
7 bus garage located at M and Half Street SE and it
8 would allow moving, as I said, the bus parking to the
9 proposed site which is located at 98 R Street SW. The
10 least would be for a period of five years only.
11 During this time OP and WMATA are sure that then can
12 find a more permanent solution for where the bus
13 parking can be located.

14 This initiative will be consistent with
15 District efforts to facilitate the construction of the
16 new baseball stadium as well as to insure efficient
17 WMATA operations. The new site is considered suitable
18 for WMATA bus parking especially on a temporary basis
19 and this parking, as I mentioned, is needed
20 immediately to replace the current one located on the
21 ball park stadium site. OP further recommends that
22 WMATA insure that all busses accessing the site do so
23 via 1st Street SE, South Capitol Street and Potomac
24 Avenue. This is because we want to make sure that
25 WMATA can avoid having busses pass through the

1 existing residential neighborhood which is located
2 generally north of Q Street and west of South Capitol
3 Street.

4 Finally, WMATA is also encouraged to work
5 with the District Department of Transportation to
6 insure that this adequate access through areas that
7 are not residential can happen as D-DOT undergoes
8 street reconstruction in the area and this
9 reconstruction will include portions of South Capitol
10 Street, 1st Street SE and Potomac Avenue within the
11 time frame that we are considering. And that's the
12 end of my presentation, and we're available for
13 questions. Thank you.

14 VICE-CHAIRPERSON HOOD: Okay, thank you,
15 Mr. Lawson. Ms. Schellin, Do we need to waive our
16 rules or was this earlier --

1 something earlier, Mr. Lawson?

2 MR. LAWSON: Yeah, my apologies, there was
3 a mistake in the square and the lot number in the
4 original Office of Planning report. The square and
5 lot number in the notification was the correct one.

6 VICE-CHAIRPERSON HOOD: Okay, good, thank
7 you. Commissioners, any questions of Mr. Lawson?

8 COMMISSIONER PARSONS: I do. Now, the bus
9 garage, I'm looking at your Attachment 1. The bus
10 garage is in the next square to the north, the
11 existing garage. And that has nothing to do with --
12 its future has nothing to do with this, correct?

13 MR. LAWSON: That's correct. And in fact,
14 the existing bus parking on the baseball site mainly
15 is for busses that are utilizing the WMATA bus garage.
16 That's mostly what that -- maybe even entirely what
17 the bus parking is for. So the proposed relocation
18 would continue to be for the busses that are being
19 serviced in the garage or sorry, awaiting servicing in
20 the garage.

21 COMMISSIONER PARSONS: So they just have
22 a longer distance to travel.

23 MR. LAWSON: They would have a longer
24 distance to travel, that's correct.

25 COMMISSIONER PARSONS: Thank you.

3 years, then what happens?

4 MR. LAWSON: It's assumed that a new and
5 permanent location would be found for the bus parking
6 that could even involve a new location for the bus
7 garage itself, because as we all know, there is a lot
8 of development and changes happening down there. I
9 guess they would have the option, if that permanent
10 location hasn't been found, to come back to the Zoning
11 Commission and ask for an extension of that approval
12 but everybody is assuming that they'd be able to kind
13 of resolve the situation in the meantime.

14 VICE-CHAIRPERSON HOOD: Okay.

15 MR. LAWSON: If the bus garage itself does
16 move, obviously, the need for the parking will go away
17 because the parking will go with the new location for
18 the bus garage.

19 VICE-CHAIRPERSON HOOD: Okay, Mr. Lawson,
20 are you aware of any other reports to the -- I mean,
21 other government agency reports, because I didn't see
22 any?

23 MR. LAWSON: We did not receive reports
24 from any other government agency.
