CHAIRPERSON MITTEN: Good evening, ladies and gentlemen. This is a special public meeting of the Zoning Commission of the District of Columbia for Monday, January 30th, 2006. My name is Carol Mitten and joining me this evening are Vice-Chairman Anthony Hood and Commissioners Michael Turnbull and Greg Jeffries.

We have a very brief agenda. The first item for final action is Zoning Commission Case Nr. 05-27.

Mrs. Schellin, did you have anything you wanted to share with the Commission?

MRS. SCHELLIN: Nothing.

CHAIRPERSON MITTEN: Okay. So what we have is a submission from the applicant that we had requested when we had taken this up at our -- I guess when we took it up at our January meeting. Yes, January 9th meeting. And so the drawings that are attached to the applicant's January 19th letter I think depict what we were looking for, which is the two lane parking garage entrance coming from Nebraska Avenue without the widening of Nebraska Avenue. Because if you recall, we had, in reviewing

1 the applicant's proposed findings of fact and
2 conclusions of law, concurred with their statements,
3 at least at this time, that we were not endorsing
4 the idea of widening Nebraska Avenue.

5 So that was the only thing that we had
6 outstanding.

7 Are there any questions or comments

8 vote 4 to 0 to 1 to approve Zoning Commission Case
9 Nr. 05-27 for final action. Commissioner Mitten
10 moving, Commissioner Hood seconding, Commissioner
11 Jeffries in favor and Commissioner Parsons in favor
12 by absentee ballot. Commissioner Turnbull not
13 voting, having not participated.

16 correspondence that's come in in Case Nr. 05-20 and
17 I've recused myself from that case and so I'll turn
18 the mike over to Vice-Chairman Hood.

22 request from the Office of Property Management,
23 Zoning Commission Case Nr. 05-20 asking us to reopen

6 about where would it locate. And it's mentioned
7 that they would give us something later on once all
8 the parties involved decide where they're going
9 relocate.

18 COMMISSIONER JEFFRIES: Aye.

19 VICE-CHAIR HOOD: Any opposition?
